
Dear Ms. Dortch:

On March, 16, 2011, Mike Rollins, Chief Financial Officer of eLandia Group, parent company of AST Telecom, LLC d/b/a BlueSky Communications (“BlueSky” or the “Company”), David LaFuria and the undersigned, counsel to BlueSky, met with Trent Harkrader, Amy Bender and Ted Burmeister of the Wireline Competition Bureau (“Bureau”) and Tom Buckley and Mike Stephens of the Office of Managing Director (“OMD”) regarding the February 8, 2011 Letter (“Feb. 8 Letter”) from Sharon Gillett, Chief, Wireline Competition Bureau, to Karen Majcher, Vice President, High-Cost and Low Income Division at the Universal Service Administrative Company (“USAC”), directing USAC to adjust the interim cap on high-cost universal service support for competitive eligible telecommunications carriers (“CETCs”).

BlueSky representatives explained how the adjustment being made to American Samoa’s CETC cap level and future collection initiatives described in the Feb. 8 Letter may affect the Company’s financial metrics, operations and future investments by BlueSky in American Samoa. Company representatives also encouraged Commission staff, in coordination with USAC, to consider alternative collection options.
