On Friday, April 1, 2011, Jonathan Foxman, Julia Tanner of MTPCS, LLC ("MTPCS"), along with undersigned counsel, met with Margaret McCarthy, Angela Kronenberg, Brad Gillen, Carol Matthey, Scott Mackoul, Margaret Wiener, Amy Bender, Cynthia Bryant, Kenneth Burnley, Katie King, Alexander Minard, Joseph Cavender and Bill Huber.

We discussed the FCC's proposed actions in the above-referenced dockets, relating to the Mobility Fund and the Connect America Fund. In particular, MTPCS urged reform that is competitively neutral and recognizes the critical need for improved mobile broadband infrastructure in rural America. MTPCS also urged the Commission to rationalize the fund by implementing full portability, so that more support flows toward the services consumers are using, and wish to have access to.
