

The Catholic Diocese of Raleigh is requesting a waiver from the FCC on closed-captioning requirements. The Diocese has begun production of a weekly 30-minute news/magazine program that it is being broadcast on community access cable channels on Time-Warner Cable systems, available in limited parts of its 32,000 square mile coverage area. Because community access is not available in the rural areas, the Diocese is looking to purchase broadcast time on a small CW affiliate located in Greenville, NC in order to provide the program to small communities in outlying areas. The program is scheduled to be broadcast at 7:00 a.m., Saturday mornings.

The Diocese has very limited production facilities and produces this program on a budget of approximately \$3,500 a year. The production staff includes one host/producer and one technical director, each having other duties as part of their diocesan jobs. The staff's primary function is to produce internal audio/video for Diocesan departments. The office does not have the capability or funds to provide for closed-captioning on the program titled "Catholic Perspective," which will only be broadcast on the small commercial station in Greenville, in addition to the community access channels.

In checking with two closed-caption providers, the lowest charge quoted is \$220 a week, with the highest at \$340 a week with a two-day turnaround. (Quotes included.) That is cost-prohibitive. Also, due to the limited production capability, the use of sign language interpretation is not possible.

Given these factors, the Diocese of Raleigh respectfully requests a waiver regarding closed-captioning for its television program.

4. You lay down the caption file to tape with your NLE
