
Dear Ms. Dortch:

On March 14, 2011, the FCC met by phone with broadband Internet service providers to discuss technical issues related to the Commission's trial for testing and measurement of fixed broadband performance.¹

The meeting focused on a discussion of privacy issues relating to the release of data collected in the trial. Preliminary views were shared on the scope of personally identifiable information (PII) in the trial, categories of information with research value, and discussion of PII masking and obfuscation approaches.
