



REQUEST FOR DEFERRAL OF HEARING FEE

Denton County Electric Cooperative, Inc. d/b/a CoServ Electric (“CoServ”), by its attorney, on even date herewith, has filed its Notice of Appearance in the above-captioned proceeding. Herein, CoServ respectfully requests that the Managing Director


defer any requirement that it pay a hearing fee with respect to the captioned proceeding.

Based upon established Commission precedent, a hearing fee is not required for parties, like CoServ, that are “designated for hearing in a renewal, assignment/transfer, or revocation proceeding.”¹ The rationale for this exception from payment of a hearing fee is that such “actions are in the nature of an enforcement action...and the imposition of a fee...would be inconsistent with [a party’s] right to a hearing.”²

WHEREFORE, for the foregoing reasons, CoServ respectfully requests that the Managing Director defer any requirement that it pay a hearing fee with respect to the captioned proceeding, as required under Section 1.221(f) of the Commission’s rules.³


