summary recap via the chatter et al and not all inclusive

standard mo player of innocent lives away = jessica = blonde with brown tones to her blond hair

geo location: nashville tn - diesel college geo locations off of main street east side of nashville tn

perpetuates framing me toughie the white slave for the falsified apa profile compiled out of lifestyles of the brunettes and black haired females found in arrest papers published weekly in tennessee, alabama, mississippi, west virginia, and north carolina

jessica = 100 percent voice print match - links to jeanne alexander - links to homeless commissions and social service trafficking rings with their network of cops either in collusion or misinformed by the social workers whom perpetuate trafficking toughie the white slave to the ss network with full intents to disable toughie the white slave

bio med techs are also still playing the scam of loading others bios into me with full intent to run a victims asset case for themselves within the corrupt sections of the us marshall service

once again, this is a repeat report - badge 386 - white caucasian female - nashville tn metro officer day shift in 2009 - same badge number as shoates whom framed toughie the white slave in conjunction and collusion with some of the other primary states that framed whom harmed her own physical appearance is the primary suspect for the forced muscle quaking of my face
