**Re: Notification of Ex Parte Presentation of  
Deloitte, WT Docket No. 06-150, PS Docket No. 06-229, WP Docket No. 07-100**

Dear Ms. Dortch:

On May 19, 2011, Brett Haan of Deloitte,<sup>1</sup> Karen Brinkmann of Karen Brinkmann PLLC, and the undersigned met with James Barnett, David Furth, and Genaro Fullano, all of the Public Safety and Homeland Security Bureau, to discuss the Commission's pending rulemaking in the above-referenced proceeding.

During our meeting, Deloitte explained that its interest in the Commission's efforts to launch the 700 MHz public safety broadband network ("PSBN") arose from Deloitte's current involvement in the 800 MHz re-banding transition, as well as its experience in the tax, audit, risk, and forensic accounting fields. Deloitte then summarized the positions taken in its comments and reply comments regarding the critical need to establish a well-defined governance framework for the PSBN and, separately, to appoint an administrator to support the governance structure of the network. Deloitte noted that widespread agreement exists among stakeholders that creating a governance structure for the PSBN should be a top priority and discussed potential models that have been proposed.
