CTC Telcom, Inc. dba Mosaic Telecom ("Company") is a provider of Commercial Mobile Radio Service (CMRS) that has chosen to deploy a handset-based location technology for E911 service. Pursuant to Section 20.18(h)(2) of the FCC's Rules, and as specified in Paragraphs 7-16 of the Wireless E911 Location Accuracy Requirements *Order*, DA 11-1125 (*rel.* June 28, 2011), we hereby notify the Commission, the Association of Public-Safety Communications Officials-International, Inc. (APCO), the National Emergency Number Association (NENA) and the National Association of State 9-1-1 Administrators (NASNA) that we do not intend to file for exclusion from the FCC's E911 Phase II accuracy requirements in any county or PSAP service area at this time.

Should there be any changes in the Company's exclusion list, we will inform the Commission within 30 days of such change, in accordance with the Commission's Rules.
