On behalf of MetroPCS Communications, Inc. ("MetroPCS" or "Company"), and pursuant to Section 1.1206 of the Commission's Rules, 47 C.F.R. § 1.1206, this is to provide notice of an *ex parte* telephone conference call held on June 29, 2011 in connection with WT Docket No. 11-65. Attending the call on behalf of MetroPCS were Michelle Johnson, Kevin Nelson, Mark Parrott, Garreth Sarosi, Terri Smith, Steven Patterson, and Alice Zhang, at MetroPCS, and Kimberly A. Lacey and the undersigned outside counsel to the Company (the "MetroPCS Representatives"). Specifically, the FCC Representatives requested clarification regarding certain of the Highly Confidential market level subscriber data, network quality data, device sales, porting data and billing data previously provided by MetroPCS in response to the Data Requests.
