Dear Ms. Dortch:

On Monday, September 19, 2011, several members of the National Association of Regulatory Utility Commissioners ("NARUC") had three separate meetings with FCC representatives. Last Wednesday night, NARUC filed the required notice of the meetings. However, State participants in the meetings discovered some deficiencies in the filing. Specifically, the Wednesday night filing (1) failed to list two FCC representatives that attended one of the meetings, (2) provided a weblink to a 2010 Ball State University white paper instead of the 2011 paper distributed during the meetings, (3) did not include a reference to one argument discussed during the meetings.

To correct these errors, as well as several wording changes in the arguments presented in the original document, I am filing (1) a corrected copy of the September 21 notice, (2) another copy of the Loube affidavit and (3) a scanned copy of the 2011 Ball State University white paper provided by Commissioner Landis to the attendees of the various meetings (as it is not yet available online).

I am also forwarding copies of this ex parte to the FCC representatives attending the meetings and asking them to assure that I have adequately covered the arguments presented.
