Pursuant to 47 C.F.R. §§ 63.24(e)(4), 63.03 and 63.04 of the Rules of the Federal Communications Commission ("FCC" or the "Commission"), United Communications Holdings, LLC ("UCH LLC") (FRN 0020970117) hereby notifies the Commission of the consummation of the transfer of control of the international and domestic Section 214 authorizations held by UTC Long Distance, LLC ("UTC LD, LLC") (FRN 0005023940) to UCH LLC, effective August 23, 2011. As required by 47 C.F.R. § 63.24(e)(4), an additional five (5) copies of this letter are enclosed herewith.


