**SECTION 63.71 APPLICATION OF BELLSOUTH TELECOMMUNICATIONS, INC.
D/B/A AT&T SOUTHEAST**

AT&T Inc. on behalf of its affiliate, BellSouth Telecommunications, Inc. d/b/a AT&T Southeast ("AT&T") applies for authority under Section 214(a) of the Communications Act, as amended ("the Act"), 47 U.S.C. § 214, and Section 63.71 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. §63.71, to discontinue SMARTGate service a/k/a SPA Managed Shared Ring Network service throughout its service territory in Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee.

As required by Section 63.71(a) and (b) of the Commission's rules, AT&T is providing the following information:

Date of Planned Service Discontinuance (47 C.F.R. § 63.71(a)(2), (b)(2)):

AT&T will no longer offer these services to new customers on or after November 30, 2011, subject to Commission approval of this application. Existing customers may retain their services until July 1, 2014 pursuant to the terms and conditions of their existing service agreement.

Points of Geographic Areas of Service Affected (47 C.F.R. § 63.71(a)(3), b(2)):

BellSouth SMARTGate service will be discontinued throughout its service territory in Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee.

Brief Description of Type of Service Affected (47 C.F.R. § 63.71(a)(3), b(2)):

SMARTGate service is a managed high capacity shared network service capable of providing a transport link with high performance and reliability parameters and a level of redundancy/diversity designed to limit a single event from interrupting service.

The equipment that supports AT&T's SMARTGate service was declared end of sale by the manufacturer. As a result, AT&T is discontinuing this service but plans to offer SMARTRing, DS3, OCN or Ethernet services as alternative service arrangements. Therefore, the public convenience and necessity is not impaired by the discontinuance of this service because AT&T offers ample alternative services.

Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. §63.71(b)(3)):

Currently, AT&T has one subscriber on this service and sent the customer notification of its intention to discontinue this service by letter on September 12, 2011 via U.S. Mail. A copy of the customer notification is attached hereto as Attachment A.

In addition, copies of this Application are being sent, first class U.S. Mail, to the public utilities commission and governor of each state in which discontinuance is proposed and also to the Special Assistant for Telecommunications to the Secretary of Defense, as required by 63.71(a) of the Commission's rules.

Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):


AT&T offers SMARTGate service pursuant to dominant carrier regulation.

**Important Notice Regarding Discontinuance of
SMARTGate Service (a.k.a. BellSouth SPA Managed Shared Ring Network)
Effective November 30, 2011**

Thank you for using AT&T for your business service needs. We want to make you aware of planned changes to your SMARTGate Service* (a.k.a. BellSouth SPA Managed Shared Ring Network) which will require coordination and action by you in the near future.

Our records indicate active SMARTGate Service on the following Sprint Billing Account Numbers (BANs):



In light of evolving market conditions and network platform equipment nearing End of Life (EOL), AT&T has elected to discontinue offering SMARTGate Service. It will be grandfathered and withdrawn from offer to all new customers in AT&T Southeast (AL, FL, GA, KY, LA, MS, NC, TN, SC) on November 30, 2011 (subject to approval by the Federal Communications Commission).

Effective November 30, 2011, the following service restrictions to existing SMARTGate service will also apply:

1. Existing customers may not purchase additional SMARTGate service arrangements; however, they may continue to purchase additional On-Net and Off-Net circuits and directly related elements associated with an existing SMARTGate Service, subject to existing capacity availability, for the remainder of any term commitment, including any contract, term plan or other applicable arrangement (collectively, "term commitment")
2. Existing service will be provided according to all applicable rates, terms and conditions for the remainder of any term commitment
3. Upon the expiration of any term commitment, service will be provided on a month-to-month basis at the then-applicable month-to-month rate until service is discontinued (currently planned for July 1, 2014).
 - a. No new or additional term commitments of any kind, including any otherwise available renewals, extensions or renegotiations, will be available.
