Dear Ms. Majcher:

On May 23, 2001 in CC Dockets Nos. 96-45 and 00-256, the Federal Communications Commission (Commission) modified its rules for receipt of high cost universal service support for the Nation's rural telecommunication carriers. The Commission's order requires the New York State Public Service Commission ("NYPSC") to annually certify that all eligible telecommunications carriers in New York State are using universal service support for the provision, maintenance, and upgrading of facilities and services, consistent with section 254(e) of the Telecommunications Act (Act) by October 1, 2011.

Enclosed is the list of the thirty-nine (39) New York State telecommunication carriers the NYPSC has determined meet the necessary requirements under section 254(e) of the Act and are eligible for high cost support for the year 2012.
