Pursuant to Sections 1.1203(a)(1), 1.1204(a)(10)(iv) and 1.1206(b)(2)(v) of the Commission's Rules, 47 C.F.R. §§ 1.1203(a)(1), 1.1204(a)(10)(iv) and 1.1206(b)(2)(v), the undersigned, representing Integra Telecom, Inc., hereby submits this written *ex parte* presentation in the above-referenced dockets in response to a request made via telephone by Zac Katz, Chief Counsel and Senior Legal Advisor to Chairman Julius Genachowski, on October 24, 2011.

Mr. Katz requested information regarding the financial impact on competitive LECs of a reduction of intrastate terminating access rates to interstate terminating access levels by July 1, 2013, as proposed in the America's Broadband Connectivity Plan.¹ Integra Telecom, Inc. has found that, as a result of this proposed reduction, it will lose approximately [BEGIN CONFIDENTIAL] [REDACTED] [END CONFIDENTIAL]
