Dear Ms. Dortch:

On behalf of Joint Applicants Education Networks of America, Inc., its wholly-owned subsidiary ENA Services, LLC (“Transferors” or, collectively, “ENA”) and ENA Holding Corporation (“Transferee” or “ENA Holding”) (collectively “Applicants”), and at the request of Mr. Christopher Sova of the Wireline Competition Bureau, this is to supplement the Applicants’ Application for Transfer of Control under Section 214 in the above-referenced proceeding to provide the following information:

1. At pages 4-5, item (4) of the Application:
  - a. ENA Investors, LLC, which holds a 13.8% interest in ENA, is a fund made up of accredited investors, none of whom owns 10 percent or more of the entity. All of the investors are US citizens. The fund is managed by Ravenswood Capital Management LLC, which is owned by Daniel Kanter and David Abraham, 2905 Harrison, Evanston, IL 60201, both of whom are US citizens.
  - b. Pre-closing, Transferee ENA Holding Corporation is wholly owned by MSouth Equity Partners II, L.P. and is not currently a telecommunications provider. Upon closing, Cumberland Valley Farm will be admitted as a member with an estimated 12.5% interest in Holding.
2. At page 7, item (8) of the Application: The Application meets the requirements for streamlined processing under 47C.F.R. § 63.03(b)(2)(ii), in that upon consummation of the transaction the Transferee will have a market share in the interstate, interexchange market of far less than one percent (1%) of the nation's

subscriber lines, will provide competitive telephone exchange services or exchange access services (if at all) exclusively in geographic areas served by a dominant local exchange carrier that is not a party to the transaction, and neither of the Applicants is dominant with respect to any service.
