Dear Ms. Dortch:

Pursuant to Section 64.1120(e) of the Commission's rules, 47 C.F.R. § 64.1120(e), NewPhone Wireless, L.L.C. ("NewPhone Wireless"), by its counsel, respectfully notifies the Commission that NewPhone Wireless intends to acquire a portion of the customer base of Image Access, Inc. d/b/a NewPhone ("NewPhone") which provides telecommunications services in multiple states, including Louisiana.¹ NewPhone Wireless is complying with the Commission's rules and procedures governing compliance with section 258 of the Communications Act of 1934, as amended, including the provision of advanced written notice to affected retail customers. In conformity with Commission rules, NewPhone Wireless provides the following information:

Parties to the Transaction: The parties involved in the transaction are Image Access, Inc. d/b/a NewPhone (the Assignor) and NewPhone Wireless, L.L.C. (the Assignee).

Types of Telecommunications Services Provided to the Affected Subscribers: NewPhone provides wireless services to a limited number of retail end user customers

(NewPhone customers subscribing to other services are not included in the transaction).
NewPhone Wireless will provide the same wireless services to these subscribers.

Date of Transfer of the Subscribers to Acquiring Carrier: NewPhone intends to transfer the affected subscribers to NewPhone Wireless on or about December 8, 2011. No regulatory approvals are required for the proposed transaction (neither NewPhone nor NewPhone Wireless provide international services to their subscribers).

Attached to this letter are (a) NewPhone Wireless's certification of compliance with the requirements of the Commission governing transfers of subscribers, and (b) a copy of the notice sent to the affected subscribers, as required under the rules. The customer notices were mailed to the affected retail customers between Friday, November 4, 2011 and Monday, November 7, 2011.



IMPORTANT NOTICE REGARDING YOUR WIRELESS TELEPHONE SERVICE

November 7, 2011

We are pleased to announce that, beginning **on or about December 8, 2011**, your wireless telecommunications service, formerly provided by Image Access, Inc. d/b/a NewPhone (“NewPhone”), will be provided by NewPhone Wireless, L.L.C. (“NewPhone Wireless”).

Your services will not be affected. The same rates, terms and conditions will apply. You will continue to use the same telephone numbers you currently do, and there will be no fees applied in connection with this transfer of your service. Notice of any future changes in rates, terms and conditions of service will be provided to you as required by law.

No action is required on your part. You may choose another carrier. However, if you have a term contract with NewPhone, you will still be responsible for any applicable early contract termination charges if you choose a service provider other than NewPhone Wireless.

If you have placed a “freeze” on your NewPhone services to prevent an unauthorized transfer to another carrier, it will be automatically lifted to implement this transfer to NewPhone Wireless. You must contact your new service provider (NewPhone Wireless or other service provider that you choose) to reestablish freeze protection, if available, after the transfer.
