A Prehearing Conference was held on October 25, 2011, pursuant to Presiding Judge's agenda in *Order* FCC 11M-27, released September 26, 2011. The rulings that were made on-the-record are memorialized below.

2011

- November 4¹ - Maritime to provide Bureau counsel and SkyTel counsel with copies of all assignment contracts and leases that were or will be provided to the bankruptcy court.
- Maritime to provide copies of evaluations/estimates of the value of Maritime Communication licenses, including those prepared by Maritime's agent(s) and those prepared by creditors and/or lenders (e.g. bank).²
 - Maritime to provide all documents within Maritime's possession or control that were used in connection with a 2008 assessment of Maritime's debt to be 24 million (including \$6 million owed to DePriests)
 - Maritime to provide all documents within Maritime's possession or control that were used in connection with a Pinnacle Bank assessment of Maritime's debt at \$13 million.
 - Maritime to provide same documentation for all other assessments of debt, if any.
- November 14 - Maritime to provide complete responses to Bureau's Request for Admission of Facts and Genuineness of Documents, filed May 13, 2011. See *Memorandum Opinion and Order FCC 11M-23*, released August 10, 2011.
- December 6 - Status Report of bankruptcy to be served on all counsel. The Status Report should confirm that Maritime expects to conclude bankruptcy application process by the required date in January 2012.


- January 20 - Parties to complete discovery on *HDO* issue on alleged failure of timely construction and alleged discontinuance of usage.

¹ Delivery of documents shall be by **12 noon**. Copies shall also be provided to each of the applicant parties by **November 8, 2011**.

² Maritime shall use its best efforts to obtain copies not in its immediate possession or control, and shall disclose to Bureau counsel, SkyTel counsel, and each counsel of record, the name, title, address and telephone number of each person who prepared such estimates
