FURTHER RESPONSE TO ORDER REQUIRING ADDITIONAL INFORMATION

On November 1, 2011, the Presiding Judge released a *Memorandum Opinion and Order* (“*November 1 Order*”) which directed Interstate Power and Light Company (“IPL”) and Wisconsin Power and Light Company (“WPL”) to “file and serve signed Statements by executive


officers by 7 November 2011, which recite a commitment that the companies shall withdraw their respective applications from the official license application files maintained by the Wireless Bureau, and shall also inform the Wireless Bureau that the Applicant companies have withdrawn as parties from this hearing.” In compliance with the *November 1 Order*, IPL and WPL submitted on November 7, 2011, the Statement of Gregg Lawry, Vice President Customer Service for IPL and WPL (the “Lawry Statement”).

The *November 1 Order* also directed “that by 15 November 2011, counsel for these applicant parties shall file in this proceeding – with copies to all counsel of record and the Chief Judge – Declarations under oath affirming that the withdrawals of said applications from the Wireless Bureau have been fully effected” As IPL and WPL noted in their November 7 filing, the Commission’s Universal Licensing System (“ULS”) does not permit an *assignee* identified in a pending application to withdraw unilaterally. The *assignor*, rather than the assignee, controls the submission of such a filing. Because IPL and WPL are the proposed assignees identified in the applications pending under ULS File Nos. 0004417199, 0004419431, 0004422320, and 0004422329, they were unable to withdraw these applications on ULS as requested by the Presiding Judge. Nevertheless, in order to comply with the terms of the *November 1 Order*, the Lawry Statement recited IPL’s and WPL’s commitment to take the steps necessary to withdraw these applications and to inform the Wireless Telecommunications Bureau that IPL and WPL have requested withdrawal as parties from this hearing.

IPL and WPL were not able to confirm on ULS in time for filing on November 15, 2011 that Maritime Communications/Land Mobile, LLC (“Maritime”) had requested that each of the above-referenced applications be withdrawn. The withdrawal requests were not posted on ULS until today, and IPL and WPL have now confirmed that such requests were filed for each of

these applications. *See* Exhibit A. These requests might also be listed in the next set of public notices issued by the agency in the ordinary course, on Wednesday, November 23, 2011.

IPL and WPL therefore respectfully renew their request that the Chief Administrative Law Judge grant their *Motion to Withdraw Notice of Appearance*.


