Dear Ms. Dortch:

In response to the March 8, 2012, letter from the Chief of the Wireless Telecommunications Bureau,¹ Cellco Partnership d/b/a Verizon Wireless, SpectrumCo, LLC, Comcast Corporation, Time Warner Cable Inc., and Bright House Networks, LLC (collectively, “Applicants”) have filed under separate cover revised versions of the Confidential and Highly Confidential Commercial Agreements that were originally filed on January 18, 2012 in this proceeding.²
