In response to the March 8, 2012, letter from the Chief of the Wireless Telecommunications Bureau,¹ Cellco Partnership d/b/a Verizon Wireless and Cox TMI Wireless, LLC (collectively, "Applicants") have filed under separate cover revised versions of the Commercial Agreements that were originally filed on January 18, 2012 in this proceeding.²
