

Unfortunately, there has been little more than slow motion discovery since the last Prehearing Conference that was held on January 25, 2012.¹ Therefore, it now appears timely and appropriate to once again visit the status of readiness of the parties with respect to: (1) preparation for trying Issue 8; (2) progress made towards resolution in the bankruptcy proceeding;² and (3) unreasonable delays in discovery.

Ruling

Accordingly, IT IS NOW ORDERED that a Status Conference be held in OALJ's Hearing Room (TW A-363) at Commission Headquarters at **10:00 a.m. on Monday, March 12, 2012.**
