On March 12, 2012, David Don of Comcast Corporation, Arthur Burke of Davis Polk & Wardwell LLP, and Michael Hammer and the undersigned of Willkie Farr & Gallagher LLP met with the following Commission staff regarding the above-referenced proceeding: Jim Bird, Ty Bream, Sandra Danner, Neil Dellar, Stacy Ferraro, Lisa Gelb, Martha Heller, Pramesh Jobanputra, Paul LaFontaine, Virginia Metallo, Catherine Mataves, Paul Murray, Joel Rabinovitz, Jim Schlichting, Mitali Shah, Susan Singer, Ziad Sleem, Christopher Sova, Tim Stelzig, Joel Taubenblatt, and Aleksandr Yankelevich. During the meeting, we discussed procedures for responding to certain of the Requests for Information that were issued to Comcast on March 8, 2012. In particular, we discussed organizational charts that illustrate the management structure of various Comcast business units.

The organizational charts, which contain proprietary and non-public information, are being submitted on a Confidential basis pursuant to the Protective Order in effect in this proceeding.¹ Consistent with the instructions in the Protective Order, the Confidential version of this filing, complete with attachments, has been filed by hand under separate cover, and copies are being provided to the Wireless Telecommunications Bureau.
