**Re: Notice of Ex Parte Presentation, Applications of Cellco Partnership d/b/a/ Verizon Wireless and SpectrumCo LLC and Cox TMI Wireless, LLC for Consent to Assign Licenses, WT Docket No. 12-4**

Dear Secretary Dortch:

On March 16, 2012, the undersigned, along with Farrah Short of Mintz, Levin, Cohn, Ferris, Glovsky & Popeo, P.C., and Cody Harrison of Sabin, Bermant & Gould LLP, spoke on behalf of Bright House Networks, LLC with Joel Rabinovitz, Jim Bird, Virginia Metallo, and Neil Dellar, Office of General Counsel of the FCC; Sandra Danner, Stacy Ferraro, Paul Murray, Mitali Shah, and Joel Taubenblatt, Wireless Telecommunications Bureau; and Pamela Megna and Christopher Sova, Wireline Competition Bureau, concerning the substance and scope of the information requests directed at Bright House Networks. The discussion focused on the format and location of various financial information and operational data and documents within the company.

During the meeting, the participants also discussed organizational charts that illustrate the management structure of various Bright House Network business units. The organizational charts, which contain proprietary and non-public information, are being submitted on a Confidential basis pursuant to the Protective Order in effect in this proceeding.<sup>1/</sup> Consistent with the instructions in the Protective Order, the Confidential version of this filing has been filed by hand under separate cover, and copies are being provided to the Wireless Telecommunications Bureau. Also pursuant to the Protective Order, copies of this redacted filing are being delivered by hand to the Secretary's Office.

Pursuant to section 1.1206 of the Commission's rules, a copy of this letter is being filed electronically with the Office of the Secretary and served electronically on the FCC participants in the discussion.
