2. Date of Planned Service Discontinuance, Reduction or Impairment:

NET/COMM plans to discontinue the provision of its interexchange service upon approval of the Commission. NET/COMM understands that this application will be automatically granted on the 31st day after public notice of its filing unless the Commission notifies it to the contrary.¹

3. Points of Geographic Areas of Service Affected: NET/COMM's proposed discontinuance of its wholesale long distance termination service will affect carrier customers located in Texas.

4. Brief Description of Type of Service Affected: The Company provided wholesale long distance termination service to customers situated within the State of Texas.

5. Brief Description of the Dates and Methods of Notice to All Affected Customers:
Not Applicable. NET/COMM does not have any customers.

6. Regulatory Classification of Carrier: NET/COMM is considered non-dominant with respect to the service to be discontinued.


