

Pursuant to the requirements of 47 C.F.R. §54.313 as clarified by the Federal Communications Commission (the “Commission”) (*see In the Matter of Connect America Fund, et al., Order*, WC Docket No. 10-90, et al., DA 12-147, released February 3, 2012 (the “*Clarification Order*”), Armstrong Telephone Company – West Virginia (the “Company”), an incumbent local exchange carrier operating in rural areas of the State of West Virginia, hereby provides the following information. Should requests for additional information be made by the Commission, the Company is willing to work with the Commission to address such requests.

- A. Progress report on its five-year service quality improvement plan pursuant to §54.202(a), including maps detailing its progress towards meeting its plan targets, an explanation of how much universal service support was received and how it was used to improve service quality, coverage, or capacity, and an explanation regarding any network improvement targets that have not been fulfilled in the prior calendar year. The information shall be submitted at the wire center level or census block as appropriate. (47 C.F.R. §54.313(a)(1))**

Pursuant to the *Clarification Order* at paragraph 7, the Company will continue “to file a service quality improvement plan or annual updates” with the West Virginia Public Service Commission (“WVa PSC”) as required by the WVa PSC. *Clarification Order* at para. 7. Accordingly, the Company “is not required to send a copy to the Commission.”

- B. Detailed information on any outage in the prior calendar year, as that term is defined in 47 CFR 4.5, of at least 30 minutes in duration for each service area in which an eligible telecommunications carrier is designated for any facilities it owns, operates, leases, or otherwise utilizes that potentially affect (i) At least ten percent of the end users served in a designated service area; or (ii) A 911 special facility, as defined in 47 CFR 4.5(e). (47 C.F.R. §54.313(a)(2))**

The Company is required to file information similar to the requested information in the referenced Commission rule with the WVa PSC by no later than July 1, 2012. To the best of my information and belief, there were no unfilled requests for service received by the Company during calendar year 2011.

- D. The number of complaints per 1,000 connections (fixed or mobile) in the prior calendar year. (47 C.F.R. §54.313(a)(4))**

The Company is required to file information similar to the requested information in the referenced Commission rule with the WVa PSC by no later than July 1, 2012. Accordingly, pursuant to paragraph 10 of the *Clarification Order*, the Company reports the following information that is compliant with that required by the WVa PSC's requirements.

The Company provides the following good faith estimates of the complaints received by it in calendar year 2011. The Company received two formal complaints from the WVa PSC and 189 trouble tickets from customers regarding its local exchange service in calendar year 2011, all of which the Company believes were resolved to the satisfaction of the customer and the Company. As a result, the Company received on average approximately 6.5 complaints/trouble tickets per month per 1000 access lines.



Emergency Operations Capability

The Company provides the following information regarding central office and remote battery and emergency generator capabilities during commercial power failures within its operating areas. The Company has deployed batteries in its central offices and remotes that will produce a minimum of eight (8) hours of DC reserve power in sites that do not have a permanently installed generator. When a permanent generator is present, batteries are sized to carry the load for a minimum of four (4) hours.

Permanently installed generators are designed to come on line within seconds of the loss of commercial power. Portable generators are transported to and, at times, shared between our other sites when the loss of commercial power is expected to exceed two (2) hours.

The Company maintains permanently installed and portable back-up gasoline, diesel, natural gas, and propane powered generators. These generators provide back-up power dependent upon the availability of fuel and personnel access to the sites where needed. Generators provide sufficient power to maintain continuous service throughout the duration of the loss of commercial power absent some unforeseen breakdown. The Company maintains a sufficient quantity of portable generators to power simultaneously approximately half of our sites not equipped with a permanently installed generator. Should circumstances warrant, additional portable generators may be brought in from other Company locations or obtained locally.

Absent catastrophic failure of the network or elements of it, the Company has the capability to engage in limited rerouting of traffic based on the facilities that are damaged. In conjunction with Verizon (now Frontier), we constructed redundant fiber routes to prevent facility-caused network isolation to the access tandem. While the Company has engineered its network based on accepted industry engineering practices, changing call routing may, to some extent, permit the Company to manage traffic patterns throughout its network during emergency situations.
