Dear Senator Rockefeller:

I attach hereto a copy of the notification that we are distributing today to our third-party billing customers. As outlined in this correspondence, third-party billing by AT&T's wireline telephone companies will be restricted to (i) telecommunications services; (ii) services or goods sold by any third-party vendor that has a direct contractual arrangement for the joint or cooperative sale of such services or goods with AT&T; or (iii) contributions to any charitable organization subject to Section 501(c)(3). In addition, AT&T will continue to bill for goods and services provided by its own affiliates and those billed by or through AT&T Mobility (such as applications or downloads). Under this revised policy, effective June 28, 2012, AT&T will no longer accept new third-party billing for end user services other than those outlined above and will cease billing for existing end user services other than as outlined above by August 27, 2012.

RE: **Termination of Billing and Collection Services for Enhanced Services**

To Whom It May Concern:

This letter is to inform you that AT&T<sup>1</sup> has decided that it will first restrict, then eliminate, billing and collection services for Enhanced Services. "Enhanced Services" are defined for purposes of this letter as any products or services sold or provided by any AT&T Billing Solutions Services Customer<sup>2</sup>, or any Client of such a Customer, other than the following: (i) telecommunications services as defined in 47 U.S.C. Section 153(46); (ii) services or goods sold by any third-party vendor that has a direct contractual arrangement for the joint or cooperative sale of such services or goods with AT&T; and (iii) contributions to charitable organizations subject to 26 U.S.C. Section 501(c)(3).

After June 28, 2012, you may continue to submit charges to AT&T for Enhanced Services, but only with respect to End Users that subscribed to the Enhanced Services prior to June 28, 2012. After August 27, 2012, you may not submit charges to AT&T for Enhanced Services. (After those dates, you will continue to submit credit Adjustments associated with any such charges previously billed.)

AT&T will send you an individual notice letter and an amended version of Attachment 4, *Services Approved for Billing*, to your Amended and Restated Agreement for AT&T Billing Solutions Services separately, within the next few days.
