Included is the information you requested for our exemption. As you will see it takes about \$44232.00 to run our church, ministry and TV show annually and about \$3686.00 monthly. The TV show crosswalk alone costs us about \$20820.00 yearly and \$1735.00 monthly. Our church payroll, mortgage, insurance, utilities, and miscellaneous total about \$44232.00 annually and about \$3686.00 monthly. As you can see we are just making ends meet and do not have funds to pay for closed captioning. Included are the statements.

Due to the nature of our program it is extremely hard to get funding from anyone other than the viewers themselves. I personally have asked two local businesses to help fund our show and they declined. The only thing we have done from the beginning of our show being aired was to ask for support from the viewers. Five times a week our show is aired and it is made available for all viewers to call and offer monetary support. We have many that do. Three times per week we also offer a church service live and streaming around the world. Each and every service we ask people for support financially. They have the opportunity to give at our church or to give through pay pal online. This is how we have supported our weekly show and church. Included are the bank statements.


You will also see included three closed captioning companies that I personally approached and asked for pricing. They average \$300.00 per 30min show. This would be an undue burden of an extra \$1200.00 per month for our ministry. At these prices it would be an impossibility to be able to air our show. I also looked into buying software to do it in house but we do not have the funds to buy it or the man power to accomplish it by ourselves. Included are the statements.

In conclusion we air our show crosswalk weekly in four different cities in the state of Illinois. We offer hope and victory for all genders, races and people over the problem of sin. It would be a shame to if our show was pulled from being aired because of closed captioning. Many lives, families and communities would be greatly devastated if crosswalk would be discontinued.

#### Roll-up Captioning

Program text rolls onto the screen one line at a time. In most instances, a maximum of three lines are shown on the screen at a time. The captions are carefully synched to the spoken word and are placed onto the screen so they do not interfere with on-screen text or graphics. Roll-up captions are typically used for single speaker videos such as training or preaching programs.
