**ORDER**

Maritime has repeatedly protested that it could not comply with discovery demands of the Enforcement Bureau due to a lack of the necessary financial resources. *See e.g.* Maritime's Reply of March 28 at 5 and *infra passim*. The reason or implied justification is the pending bankruptcy. But there has been no proffer of the financial withdrawal of Maritime's owners.

The discovery sought by the Bureau that is not forthcoming is all relevant to Issue 8 (station construction and operating status). Certainly the parties and the Presiding Judge are entitled to know (1) when the construction of each licensed facility was completed, and (2) which licensed facilities are currently in operation or not.

### **Ruling**


Accordingly, IT IS ORDERED that current financial statements <sup>1</sup>(accountant certified if available) for each equity owner of Maritime, including but not limited to common and preferred shareholders, stock option holders, and any person exercising, or having the power to exercise, direct or indirect control of Maritime's business and/or operations.

IT IS FURTHER ORDERED that each Financial Statement be accompanied with a Declaration attesting to accuracy and truthfulness to the best of Declarant's knowledge and belief.

IT IS FURTHER ORDERED that each Declarant submit a copy of personal Federal Tax Returns for the years 2010 and 2011.

IT IS FURTHER ORDERED that the Financial Statements and Tax Returns shall be submitted as Confidential Documents by **2 p.m. April 16, 2012**, only to the Presiding Judge, Counsel for parties who are signers of the Protective Order, and Warren Havens.
