The Federal Communications Commission (FCC) has directed the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (USAC) to further review your application consistent with the FCC Order referenced above.

After thorough review and investigation of all the relevant facts, USAC has made its decision in regard to the FCC Remand of USAC's Funding Year 2002 Funding Commitment Decision Letter for the Application Number indicated above. This letter explains the basis of USAC's decision. The date of this letter begins the 60-day time period for appealing this decision. If you included more than one Application Number in your appeal to the FCC, please note that you will receive a separate letter for each application.

Explanation:

- In accordance with the FCC decision in the released order (DA 11-672), your appeal has brought forward persuasive information that the funding requests cited above should be approved for funding.

Funding Request Number: 876087

Decision on FCC Remand: Approved, Funding Reduced

Explanation:

- In accordance with the FCC decision in the released order (DA 11-672), your appeal has brought forward persuasive information that the funding request cited above should be approved for funding. However, funding has been reduced for the reason cited below.
- The dollars requested were reduced per vendor documentation. FRN 876087 was reduced from \$6,552.70 per month to \$6,293.71 per month. The applicant agreed to this modification during the appeal review process.

Since the Administrator's Decision on FCC Remand Letter approves additional funding for your application, USAC will issue a Revised Funding Commitment Decision Letter (RFCDL) to you and to each service provider that will provide the services approved for discounts in this letter. USAC will issue the RFCDL to you as soon as possible. If your appeal included Internal Connections at a discount level that has not yet been approved for funding, an RFCDL will be issued for those funding requests once USAC determines if there will be sufficient funds to make commitments at your discount level. The RFCDL will inform you of the precise dollar value of your approved funding request(s). As you await the RFCDL, you may share this Administrator's Decision on Appeal with the relevant service provider(s).

If your Administrator's Decision on FCC Remand Letter indicates that your appeal has been approved, but funding has been reduced or denied, you may appeal these decisions to either the SLD or the Federal Communications Commission (FCC). For appeals that have been denied in full, partially approved, dismissed, or cancelled, you may file an appeal with the FCC. You should refer to CC Docket No. 02-6 on the first page of your appeal to the FCC. Your appeal must be received or postmarked within 60 days of the date on this letter. Failure to meet this requirement will result in automatic dismissal of your appeal.
