Dear Ms. Dortch:

At a May 30, 2012, meeting with Commission staff, William Stone, Executive Director - Technology, for Verizon discussed Verizon Wireless' most recent regular update of traffic projections for its network, which incorporate more recent actual customer device, usage, and traffic data than were available when Verizon Wireless submitted its previous projections.¹ Based on these updated projections, Mr. Stone explained that the company now forecasts greater capacity constraints across its LTE network. Attached hereto is a series of maps, analogous to those Verizon previously submitted in this proceeding, updated to reflect these new traffic projections. In particular, we are submitting maps for the markets depicted in the *May 31 Ex Parte Letter* and several additional markets, with the following adjustments: (1) a set of maps depicting capacity constraints based on the new data and assuming that Verizon will be able to begin refarming PCS spectrum; and (2) a second set of maps identical to the first but assuming that the Commission consents to the AWS license assignments that are the subject of this proceeding. These maps demonstrate that the need for additional AWS spectrum is even more urgent, and the Commission should act promptly to approve these transactions.
