Installations that go over the 2 hour minimum will be charged at a rate of \$55.00 per hour with 1 hour minimum billing.** Additional services such as but not limited to: router set-up and other miscellaneous computer related work billed for at a rate of \$55.00 per hour.

Additional charges may include but not limited to: Cat5 and/or Ethernet cables for indoor / outdoor modems, WIFI Antennas, WIFI Radios, Panel Antennas, Client Bridge, Wireless Routers, and/or any additional supplies needed to complete installations.
