RE: Updated Information on Pending Petition for a Closed Captioning Exemption

Dear Ms Monteith,

I am in receipt of the request from the Federal Communications office requesting an update to the petition for exemption of Closed Captioning.

As stated in our previous correspondence, our church was organized in 2007 with limited resources. We are a growing church, but with that requires growing expenses, which include having to add additional staff to take care of the needs of our church. Attached please find a copy of our 2011 and 2012 budgets.

We are airing a 30 minute paid religious program spot on WHLT – CBS 22 in Hattiesburg, MS. This is a small marketing station that broadcasts to a limited area, less than 1,000 viewers each week. The broadcast is recorded, not live, airing only once a week and not repeated.

We are asking for exemption pursuant to Section 79.1 of the Commission's rules, 47 C.F.R & 79.1, as this compliance would impose an "undue economic burden." As defined in Section 79.1 (f) of the Commission's rules, 47 C.F.R. & 79.1(f).




