("Purple"), John Cannon and Kathleen Marcus of Stradling Yocca Carlson & Rauth met with the following Commission staff regarding the above-referenced proceeding: Jonathan Chambers, Robert Aldrich, Eliot Greenwald, and Greg Hlibok, all in the Consumer & Governmental Affairs Bureau, and Sean Lev, of the Office of General Counsel.
