Dear Ms. Dortch:

On June 18, 2012, Tribune Broadcasting Company, Debtor-in-Possession (“Tribune”), filed a Complaint for retransmission without Tribune’s consent of the signal of KDAF(TV), Dallas, Texas against East Texas Cable (“East Texas”) with respect to East Texas’s cable systems serving Canton and Smith, Texas.

The parties have reached an agreement retroactive to and effective as of January 1, 2012. As a result, East Texas has been retransmitting the signal of KDAF with Tribune’s consent throughout the current retransmission consent carriage cycle, rendering the Complaint moot. Accordingly, Tribune hereby withdraws the Complaint and requests that the Commission close this proceeding without taking any further action.
