
If loved ones long to talk with their loved ones and vice versa they are "forced" to pay exorbitant, even usurious like rates.

RE: This is a public comment for the Wright Petition (CC Docket #96-128).

Dear Mr. Genachowski:

I have been incarcerated in the Federal Bureau of Prisons for close to 12 years now. The cost of making a phone call is way to expensive for me and those with me considering that working in prison does not pay much at all.

Since my criminal sentence ended November 22, 2006, and I was detained civilly for 5.5 years before being civilly committed I have still had to phone the high cost of making a phone call here at FCI Butner I Medium. The cost of a phone call from a federal facility is .23/minute for long distance and maybe a few cents cheaper if the call is local. International calls cost .99 a minute and this creates a burden for those with families who are not in the United States.

I would urge you and the FCC to take control of the price gouging that is being done on the cost of phone calls for those who are incarcerated throughout the United States. The cost of calls has forced my family to eliminate the ability to receive collect calls because the cost ended up being almost \$10.00 per call.

Thank you for your time and efforts in considering this problem.

My Pin# to authorize calls ~~fell~~ ^{fell} into the hand(s) of my bunkbed mate, ~~they~~ ~~bracketed~~. My brother has been called, & he can't be sure who it is until he accepts the collect call.

Twice, he's talked to an inmate or 2 & felt empathy or sympathy as insensitive commentary was aimed at him. There's a connection charge when he picks up, & then per minute I surmise. Now, he quote, "doesn't want to get involved with whoever's calling from the IDUC, but fortunately hasn't blocked ^{my} calls. The ~~calls~~ ^{costs} are split between monetary reserves he has of mine, & his own bacon from employment. He's not going to visit, and has devoured all his energizers as enmity in his household ^{is abusing} ~~is~~ bugging him at the same damn time of the calls.*

I am one step from being told, "Go away! It's too late," despite being prepared & awake (Matthew 25:13, New Testament, Bible). ~~by DIRECTLY~~
