
Re: Notice of Ex Parte Conference

Dear Ms. Dortch:

Yesterday the undersigned, on behalf of Flat Wireless, LLC and its affiliates, had a telephone conference with the following members of the Wireline Competition Bureau Pricing Division staff: John Hunter, Randolph Clarke, Rhonda Lien, and Max Schackman. The subject of the conference was a discussion of the extent to which the Commission's "Transformation Order" (the November 18, 2011 *Report and Order and Further Notice of Proposed Rulemaking* in the above-referenced Dockets) mandates the use of bill-and-keep as a payment mechanism for transiting traffic between LECs and CMRS carriers.

During the course of the discussion, the conferees reviewed the pertinent language in the Transformation Order and discussed hypothetical traffic exchange situations to understand how transiting situations between LECs and CMRS carriers might occur and how the Order's bill-and-keep paradigm might apply in those situations.
