Dear Ms. Dortch:

Pursuant to Section 64.1120(e) of the Commission's rules, 47 C.F.R. §64.1120(e), undersigned counsel for Windstream Corporation ("Windstream") hereby notifies the Commission that on or after September 21, 2012, its subsidiary, Windstream Communications, Inc. ("Windstream Communications"), will transfer certain interexchange customers to another Windstream subsidiary, Windstream Kerrville Long Distance, LLC ("Windstream Kerrville LD"). Windstream Kerrville LD and Windstream Iowa are existing subsidiaries of Windstream and are transferring customers due to a change in wholesale vendors. Pursuant to Section 64.1120(e), Windstream provides the following with respect to the transfer of customers from Windstream Kerrville LD to Windstream Iowa:

1. Names of the Parties to the Transaction:

Windstream. Windstream is a publicly-traded Delaware corporation headquartered in Little Rock, Arkansas and is the holding company owner of subsidiaries that offer a number of communications and entertainment services, including local exchange and toll service, to customers throughout the Nation.

Windstream Communications. Windstream Communications is a subsidiary of Windstream that offers interexchange and local service, including stand-alone interexchange service, in, among other places, Texas.

Windstream Kerrville LD. Windstream Kerrville LD is a subsidiary of Windstream which offers interexchange services in Texas.

2. Types of Telecommunications Services Provided to Affected Customers:

The affected customers subscribe to Windstream Kerrville LD interexchange service, but do not subscribe to the local service of any affiliate of Windstream Kerrville LD.

3. Date of the Expected Transfer:

Affected Windstream Kerrville LD customers will be transferred to Windstream Iowa on or after August 21, 2012.

4. Certification of Compliance:

Windstream Kerrville LD hereby certifies its compliance with: (i) the requirement to provide advance subscriber notice in accordance with Section 64.1120(e)(3) of the Commission's rules, 47 C.F.R. §64.1120(e)(3); (ii) the obligations specified in that subscriber notice; and (iii) all other statutory and Commission requirements that apply to this notification process.

5. Customer Notification:

A copy of the customer notification, which was sent to affected Windstream Kerrville LD subscribers at least 30 days prior to the change in service date, is attached hereto.
