Dear Ms. Dortch:

On August 29, 2012, Douglas Smith, Chairman and Chief Executive Officer of LightSquared, Jeffrey Carlisle, Executive Vice President – Regulatory Affairs and Public Policy of LightSquared, and James Barker and the undersigned of Latham & Watkins LLP, outside counsel to LightSquared, met with the staff identified below.

In that meeting, LightSquared explained (i) its continuing desire and intention to deploy a nationwide 4G wireless broadband network, (ii) the significant public interest benefits that would flow from the deployment of LightSquared’s authorized network, including how its wholesale business model would both significantly enhance competition in the wireless industry and facilitate the development of innovative wireless applications, and (iii) the compelling need to find appropriate solutions to the current issues involving LightSquared.

LightSquared expressed its willingness to consider a comprehensive solution that would allow it to deploy a nationwide 4G wireless broadband network while addressing concerns raised by the GPS industry. LightSquared provided an overview of the proposals that are detailed in (x) its May 17, 2012 Notice of Ex Parte Presentation in the L Band Proceedings (pages 4-6), and (y) its April 25, 2012 letter (pages 3-4), May 17, 2012 comments (pages 4-8), and June 1, 2012 reply in the 2 GHz Proceedings (pages 5-6).
