Dear Ms. Dortch:

On May 11, 2012, Blue Jay Wireless, LLC (“Blue Jay”) submitted its Compliance Plan outlining the measures it will take to implement the conditions imposed by the Commission in its *Lifeline Reform Order*.¹ On July 5, 2012, July 23, 2012 and August 14, 2012, Blue Jay revised its Compliance Plan to provide additional details and clarifications. In the July 23, 2012 revision, Blue Jay indicated that it had plans to begin providing non-Lifeline wireless service within 45 days.

Blue Jay hereby informs the Commission that as of today it has launched non-Lifeline wireless services and begun signing up customers. Blue Jay reiterates its request for expeditious approval of its Compliance Plan.
