

**AFFIDAVIT OF CITY OF KETCHIKAN, KETCHIKAN PUBLIC UTILITIES REGARDING COMPLIANCE WITH 47 U.S.C. § 254(E) FOR STUDY AREA CODE 613013**

Now comes Jeffrey D. Martin, who, being duly sworn, deposes and says under oath as follows:

1. My name is Jeffrey D. Martin. I am the Assistant General Manager for the City of Ketchikan, Ketchikan Public Utilities (KPU).
2. In my present capacity, I have personal knowledge and experience regarding KPU's regulatory affairs, including, without limitation, KPU's receipt and use of Federal High Cost Support funds.
3. I am the corporate officer at KPU authorized to attest to KPU's use of Federal High Cost Support funds.
4. KPU is an eligible telecommunications carrier within the meaning of 47 U.S.C. § 214(e) and is eligible to receive federal universal service support pursuant to 47 U.S.C. § 254(e). *See In re: Designation of Eligible Telecommunications Carriers,*



5. KPU files this affidavit in compliance with 47 CFR 54.314, which requires carriers not subject to state jurisdiction to certify to the FCC that all Federal High Cost Support provided to such carriers was, and will be, used only for the provision, maintenance and upgrading of facilities and services for which the support is intended pursuant to 47 U.S.C. § 254(e).

6. KPU hereby states that during 2011 it used, and during 2013 it will use, Federal High Cost Support only for the provision, maintenance and upgrading of facilities and services for which the support is intended pursuant to 47 U.S.C. § 254(e).




