The VSCC certifies that the ETCs identified on the attached list provided attestations that all federal high-cost support provided to such carriers within Virginia was used in the preceding calendar year, 2011, and will be used in the coming calendar year, 2013, only for the provision, maintenance, and upgrading of facilities and services for which the support is intended.¹
