REQUEST FOR EXEMPTION FROM COMMISSION'S CLOSED CAPTIONING RULES  
CGB-CC-XXXX  
CG Docket No. 06-181**

The stations, UAN and affiliates, is filing a petition for exemption for its programming from the closed captioning requirements, pursuant to Section 79.1 of the Commission's rules, 47 C.F.R. § 79.1. Petitioner's annual revenue is under the requirement to provide closed captioning.

This station broadcasts local religious 28.30 programs for pastors and churches on a twenty four hour schedule. Also live streaming over the internet. The speakers pay for their programs monthly. This station meets the exemption requirement of annual revenue under \$3,000,000. Please find attached a Profit and Loss Statement for Universal Affiliates Network. The programming basis is religious for the most part. The program speakers are made up of local pastors and speakers. This station can not therefore pass on the costs of closed captioning to these speakers. This would impose an economically burdensome cost upon them. This station would then incur a significant difficulty in trying to pay for this expense. We have searched the costs of closed captioning for these programs and this would result in a cost of \$300. per program extra. Also, costs of hiring extra encoders and buying software and hardware. We are requesting that this channel and its affiliates receives an exemption from being required to provide closed captioning .


