RE: New Petition CC Exemption for Television Program "Revive"

Dear Secretary,

I respectfully re-submit this updated information for exemption from Closed-Captioning .
Section 79.1 d.8, d.11 and d.12, is the basis for our request.

This is a locally produced, non-news show. The "electronic news room" technique of captioning is unavailable. Previously, this was denied and stated that we did not appear to meet the FCC's definition of a video programming distributor. If we are not a distributor, then we should be exempt.

The average weekly financial burden would be, at the least, \$123, and that is an introductory offer. The yearly cost would be much more than 2% of our gross revenue for the media ministry

In addition, Section 79.1 d.12 indicates that any programmer producing revenues of \$3,000,000 or less, is exempt. Obviously, we fall into this category. We will be forced to stop our weekly television program if we are not granted this exemption. The weekly 30-minute program is a mix of music and spoken word.

We have not expended anything on captioning at this point, only sought quotes from several captioning services. I am enclosing one example of proposed captioning expense of \$123 (plus) per program. This is an introductory pricing quote. A yearly expense of at least \$6396, would be incurred, not including additional expenses associated to produce the program. That is far greater than the 2% (\$1214.53) of the gross income of \$60,726.47, of the Ministry.

The financial overview included with this petition covers the entire media department profit and loss. As you can see, we do not meet our expenses with income generated. It is an outreach ministry (i.e. missions).

I ask you to reconsider this petition. Your exemption will allow us to continue to reach our community to the best of our ability. Thank you for your consideration with this matter.


