On October 9, 2012, XO Communications, LLC, ("XO Communications"), by its attorneys and pursuant to section 63.71 of the Federal Communications Commission ("Commission") rules, 47 C.F.R. § 63.71(a), filed a Section 63.71 Application for the discontinuance of selected interstate domestic dial-up services. By letter dated October 17, 2012, XO Communications amended its Application. The undersigned counsel for XO Communications has spoken with Commission Staff about the Application and submits this letter to clarify the XO Communications entities, and confirm the states, affected by the discontinuance.


XO Communications hereby clarifies that the services being discontinued have been offered by all three of XO Communications' operating subsidiaries: XO of Virginia, LLC, XO Telecommunications of Nevada, LLC and XO Communications Services, LLC. XO Communications also confirms that the discontinued services are not offered in any states other than the twenty-five (25) states, and the District of Columbia, that were identified in XO Communications' October 17, 2012 Amendment to its Application.
