**PETITION FOR SPECIAL RELIEF
BY ORDER OF CARRIAGE**

Western Pacific Broadcast, LLC (“Western Pacific”), pursuant to FCC Rules 76.7 and 76.61, hereby respectfully requests that the Bureau order Verizon New Jersey, Inc. (“Verizon”) to carry local commercial television station WACP, licensed to serve Atlantic City, NJ (“WACP”), in accordance with the Commission’s must carry rules and policies on Verizon’s cable system(s) within the Philadelphia, PA designated market area (the “DMA”) for the remaining duration of the current must carry election cycle, expiring December 31, 2014.

This petition is one of three petitions for special relief filed on this date against the three Verizon cable operators who operate within the DMA. The other two operators are Verizon Delaware LLC and Verizon Pennsylvania, Inc. While Verizon serves the DMA with three separate companies, Verizon interacted with Western Pacific through a single set of employees

on behalf of all three Verizon cable operators and the facts and issues pertinent to this dispute are identical for all three cable operators.

In support of this petition, the following is respectfully submitted:

I. Factual Background

This Petition is the unfortunate culmination of over 4 months of frustrated attempts by Western Pacific to obtain carriage of WACP by Verizon, in accordance with WACP's must carry rights. Western Pacific's efforts have involved, among other things, sending two letters (an election then a demand) to Verizon, sending numerous emails to Verizon, visiting Verizon's headend, and attending telephone conferences with Verizon employees. Throughout Western Pacific's interactions with Verizon, not once has Verizon raised any defense to Western Pacific's demand for statutory mandatory carriage of WACP. Indeed, Verizon has admitted that it has no defense to carriage, but continues to drag its feet, thus necessitating this petition.

WACP is a new commercial television station, which commenced operation this summer. As a result of its status as a new station, Rule 76.64(f)(4) required it to notify local cable operators of WACP's initial election of carriage status within a window 60 days prior to commencing broadcasting and 30 days after commencing broadcasting. In accordance with that requirement, Western Pacific notified Verizon by letter dated June 6, 2012 that WACP was commencing operation and elected mandatory carriage on Verizon's cable systems operating in the DMA.¹ That letter was sent by certified mail and was received by Verizon on June 11,

2012.² Under Rule 76.64(f)(4), that initial election took effect 90 days after it was made, which in the case of Verizon was September 9, 2012.

Verizon definitely knew of the carriage obligation during the 90-day notice period for carriage. Marcello Correa of Verizon's Content Acquisition and Programming Division communicated with undersigned counsel about the carriage and arranging for that carriage on June 14, 2012, by telephone message left on the undersigned's telephone at 1:16 p.m. which date is 87 days before the end of the 90-day notice period. Mr. Correa also discussed carriage with undersigned counsel by telephone on June 18th and sent an email to counsel on July 3rd to relay the name of a Verizon engineer, Mr. Anthony Van Lierop, Verizon's Sr. Network Engineer, for contact by WACP's engineer. Yet, even though Rule 76.64(f)(4) gave Verizon 90 days to take the steps required for carriage, when the 90-day notice period ended on September 9, 2012, Verizon was not carrying WACP.

Apparently, Verizon did nothing material during that 90-day notice period to prepare for carriage of WACP. During this time, WACP actively pursued contact with Verizon to determine when the carriage of WACP by Verizon would begin and to determine as early as possible if Verizon had any defenses to carriage that WACP might successfully address. Kevin Busselman, a senior engineer with Western Pacific, made several calls to Verizon's Sr. Network Engineer, Anthony Van Lierop, to determine whether the carriage of WACP presented any technical issues. He was not told there were any insurmountable issues.

Despite WACP's proactive efforts, Verizon was not responsive. At the end of the 90-day notice period, it became apparent to Western Pacific that a more formal approach would be

required to get Verizon's attention. To preserve its rights to carriage, by letter dated September 14, 2012, Western Pacific demanded carriage of WACP pursuant to FCC Rule 76.61(a)(1), which states:

(1) Whenever a local commercial television station or a qualified low power television station believes that a cable operator has failed to meet its carriage or channel positioning obligations, pursuant to §§ 76.56 and 76.57, such station shall notify the operator, in writing, of the alleged failure and identify its reasons for believing that the cable operator is obligated to carry the signal of such station or position such signal on a particular channel.³

Verizon responded to Western Pacific's carriage demand by a letter dated October 15, 2012, which says no more than "Verizon's and WACP's engineers have been working together...", that WACP's engineers will conduct on-site testing on October 17, 2012, and that "[w]e will continue to discuss carriage of WACP with the station based upon the results of Wednesday's testing."⁴ Of course, WACP had no obligation to make tests and did not do so, as under Rule 76.61(a)(2), Verizon has that obligation.

Verizon's October 15 letter completely ignores the requirements of Rule 76.61(a)(2), which sets forth in specific detail the response a cable operator must make to a carriage demand letter:

(2) The cable operator shall, within 30 days of receipt of such written notification, respond in writing to such notification and either commence to carry the signal of such station in accordance with the terms requested or state its reasons for believing that it is not obligated to carry such signal or is in compliance with the channel positioning and repositioning and other requirements of the must-carry rules. If a refusal for carriage is based on the station's distance from the cable system's principal headend, the operator's response shall include the location of such headend. If a cable operator denies carriage on the basis of the failure of the station to deliver a good quality signal at the cable system's

principal headend, the cable operator must provide a list of equipment used to make the measurements, the point of measurement and a list and detailed description of the reception and over-the-air signal processing equipment used, including sketches such as block diagrams and a description of the methodology used for processing the signal at issue, in its response.

Faced with Western Pacific's carriage demand letter, Rule 76.61(a)(2) required Verizon within 30 days after it received the letter to "either commence to carry the signal of such station in accordance with the terms requested or state its reasons for believing that it is not obligated to carry such signal or is in compliance with the channel positioning and repositioning and other requirements of the must-carry rules." Verizon's October 15 response does neither, instead points only to the notion that Verizon had somehow been working with Western Pacific when, in fact, Verizon was required to institute carriage but ignored that requirement, and failed to take timely steps to provide carriage.

The idea of conducting a further signal tests on October 17 cannot be explained as other than foot-dragging as the test date is well after the date that Verizon was required by Rule 76.61(a)(2) to provide Western Pacific with signal measurements if Verizon intended to resist carriage for lack of a good quality signal, and, more importantly, as noted in an email of Western Pacific's counsel to Verizon's counsel, a Verizon engineer told Western Pacific that there was "no problem" with the signal of WACP as received at the Verizon headend, meaning the signal was of "good quality," and Verizon's engineer also indicated that Verizon's real problem with carrying WACP was a capacity issue.⁵ Moreover, 4 days before Verizon's October 15 letter, Verizon's Anthony Van Lierop sent Mr. Kraft of Western Pacific via email a screen shot of the WACP signal which showed no interference and accordingly indicated there was no problem with the quality of the signal. The Van Lierop email continued that "long term signal reception

could be negatively impacted” if Verizon mounted the WACP reception antenna at a level below the antennas it uses to receive the other Philadelphia television station signals.⁶

In view of the foregoing, one day after receiving Verizon’s defective response, counsel for Western Pacific called counsel for Verizon to set the matter straight and sent Verizon’s counsel an email confirming what was said in the telephone call.⁷ To quote the email in pertinent part:

As discussed, the Verizon letter did not reflect current information or the obligations of the parties. WACP will not be making tests of signal quality tomorrow at the Verizon headend in the Philadelphia DMA. Mr. Anthony Van Lierop, the FIOS Network Engineer, has recently indicated to WACP that there was no signal problem, which means a good quality signal is present and no more tests are needed. Mr. Lierop did say that Verizon needed to do some tweaking (i.e. fine tuning or adjusting) to other existing equipment on its own tower to resolve a slight interference concern, and noted Verizon was separately working on what he termed a channel “capacity” issue. Resolution of the capacity issue is, of course, solely the responsibility of Verizon.

An engineer for Western Pacific, Greg Kraft, visited Verizon’s headend on October 17, 2012 and was shown the results of Verizon’s tests. By email sent that day to WACP personnel,⁸ he reported on the tests as follows:

The engineers at FIOS showed me the results of their testing today. As it stands right now, they concede that we have met the requirements to be broadcast on FIOS. Our signal to noise ratio is within bounds to meet the FCC requirements for Must Carry Laws.

They are worried about a **potential problem** if current interference were to get worse or our power level were to decrease. Our signal to noise ratio **might** get worse. This scenario could be applied to every single broadcast station they currently carry.

In short, the Verizon engineers found the signal of good quality and acceptable.

Despite these tests and their acceptable results, Verizon remained undeterred in its passive refusal to carry WACP. By email of October 24, counsel for Verizon stated that Mr. Kraft “observed on Verizon’s test equipment noticeable interference with the signal Verizon receives from WACP.” This is just not the case. As that email further states, the problem was with other unrelated equipment/antenna, and that Verizon had “contacted the subject of the interference.” And this email states, *for the first time*, that before launching WACP:

a structural analysis must be conducted to ensure that the tower and current antenna mast can support the newly proposed antenna and to assess the impact of tower loading on existing stations on the tower and public safety concerns. The current antenna structure is capable of supporting an additional 300 pounds. Although the proposed antenna for WACP weighs 150 pounds, potential icing and wind loading must be taken into account, as it is possible that these factors could overload the current antenna mast.⁹

Of course, Verizon gave no timeframe for conclusion of its structural analysis, nor does it seem likely that such an analysis could take any appreciable time. Verizon concedes it has data for its tower. The antenna’s loading drag would as well be easily discoverable. Verizon is simply foot dragging. Finally, Verizon’s counsel’s October 24 email referenced in this paragraph was echoed verbatim by an October 26 email from Verizon’s Marcello Correa.¹⁰

At this juncture, Western Pacific can only conclude that Verizon has had no intention of carrying WACP unless Verizon is compelled by the Commission to do so.

Under Rule 76.61(a)(3)(iii), Western Pacific is entitled to file this Petition within sixty days of the date that is thirty days after the date of delivery of its carriage demand letter, if the Cable Operator has failed to respond to the Carriage Request in the manner required by Rule 76.61(a)(2). A response as required by the Rule, was due by October 15, 2012. As explained

above, Verizon's response did not comply with those requirements. Accordingly, this Petition is filed within the deadline established by Rule 76.61(a)(3)(iii).¹¹

II. Discussion

Verizon has the burden of showing that WACP is not entitled to carriage if WACP is a commercial television station local to the DMA.¹² As shown below, WACP is a commercial television station that is local to the DMA.

(a) Verizon Is a Cable Operator in the DMA.

Verizon is a cable operator that operates one or more cable systems serving the DMA, as demonstrated by the Commission's list of community unit identification numbers for the counties within the DMA.¹³

(b) WACP Is Entitled to Mandatory Carriage on Verizon's Cable System in the DMA.

WACP is entitled to carriage on cable systems located in the DMA if it is a "local commercial television station," as that term is defined in Rule 76.55(c). WACP is a commercial television station that is local to the DMA. In this regard, the Station is licensed to serve the community of Atlantic City, New Jersey, which is within the same television market as the cable system(s) operated by Verizon in the DMA.¹⁴ WACP is licensed and operating on a channel

regularly assigned to its community of license, channel 4.¹⁵ Finally, WACP either delivers a good quality signal to the principal headend of the cable system(s), or is entitled to carriage despite the delivery of a lower quality signal due to the Western Pacific's undertaking to be responsible for the costs of delivering a good quality signal or a baseband video signal to the cable system(s). WACP has been operating within the DMA since June of this year and did not elect to reserve its retransmission consent rights with respect to any cable system or area of the DMA for the current must carry election cycle.

This Petition was preceded by both a written must carry election delivered to Verizon and a subsequent written demand for carriage delivered to Verizon. As explained in detail above, Verizon has not identified any defense to the request for carriage. While Verizon has offered that interference "could" result in the future, Verizon has agreed that it receives a good quality signal and has not shown any actual interference that might call the quality of the signal into question. In fact, Verizon has not supplied Western Pacific with any measurements of signal-to-noise ratios or of signal strength, even though it is Verizon's duty under Rule 76.61(a)(2) to take the measurements in accordance with Commission requirements and to provide them along with test data and related information to the TV station within 30 days of a carriage demand, if the cable operator intends to deny carriage based upon signal quality. Moreover, in instances in which interference creates a signal-to-noise ratio that is problematic, the Commission has still granted the carriage request and has required carriage to commence in 60 days, with an instruction to the parties to cooperate to resolve the interference. *Richard C. and Lisa A. Goetz*, CSR-7736-M, at 4 (July 7, 2008) (Senior Deputy Chief, Policy Division, Media Bureau).


III. Conclusion



Dear Ms. Hochstein, Mr. Shakin and Fios Programming Team:

Pursuant to Section 614 of the Communications Act of 1934, as amended, and Section 76.64(f)(4) of the rules of the Federal Communications Commission, this will inform you that Western Pacific Broadcast, LLC, the licensee of Television Station WACP, Atlantic City, NJ (the "Station") hereby elects mandatory carriage of the Station's television signal pursuant to Section 76.56(b) on all cable systems operated by any one or more of Verizon Communications Inc., Verizon Delaware LLC, Verizon New Jersey, Inc., Verizon Pennsylvania, Inc., or any or more of any of its or their direct or indirect subsidiaries or affiliates to the extent they serve the Philadelphia, PA Designated Market Area ("DMA"), including without limitation those community units listed on Exhibit A hereto. Carriage is sought solely within the DMA. The Station is a new station that is licensed to Atlantic City, NJ, which is part of the DMA. The Station is scheduled to begin commercial broadcasting on June 8, 2012. The Station will present the programming of Cannella Response Television, LLC, as well as other offerings of high quality programming. With reference to FCC Rule 76.56(b)(5), the Station will not substantially duplicate

the signal of any other local commercial television station that is carried or retransmitted on your systems within the DMA and will not have a network affiliation duplicating that of a local commercial television station carried on your systems within the DMA.

The Station is assigned virtual channel 4 and elects carriage on that channel as of right under FCC Rule 76.57. Please be advised for purposes of complying with the FCC's material degradation requirement that the station will commence broadcast with one program stream employing virtually the entire bit stream (19.4 mbps) of the channel.

The Station is a local commercial television station as to all cable systems operating in the DMA, as defined in FCC Rule 76.55(c). For purposes of that definition, please be advised that in the event that the Station does not deliver an over the air signal of good quality as specified in FCC Rule 76.55 (c)(3) to the principal headend(s) [as defined in FCC Rule 76.5(pp)] of the cable systems covered by this election, the Station will be responsible for providing equipment and bearing the costs of delivering such requisite signal of good quality to those headend(s) as required to comply with FCC Rule 76.55 (c), including without limiting the foregoing, the costs for any needed specialized equipment. Please note that this correspondence is not a demand for carriage; rather it is the election notice new stations are required to make under FCC Rule 76.64(f)(4).





This letter is being delivered to you on behalf of Western Pacific Broadcast, LLC, the licensee of local commercial Television station WACP, licensed on channel 4 to serve the community of Atlantic City, NJ. This letter is a demand for carriage under FCC Rule 76.61(a)(1).

By letter dated June 6, 2012, and received by your offices on June 7 and June 11,¹ you were informed that WACP was commencing operation as a local commercial television station in the Philadelphia, PA Designated Market Area (the "DMA") and had elected mandatory carriage status.² As

stated in that letter, as a cable operator within the DMA, FCC Rule 76.64(f)(4) required you to commence carriage of WACP by the date that is 90 days after that election. That 90 day period has ended, and our investigation has revealed that your system(s) within the DMA is not carrying WACP. This failure to commence continuous carriage within that 90 day period is a violation of FCC Rules, as well as the Communications Act of 1934, as amended. Although you received our carriage election notice, we have not received any communication from you indicating that you have a valid defense to carriage.

To be clear, WACP is entitled to carriage on your cable system(s) within the DMA. WACP has properly elected must carry status, and is a commercial television station which is local to the DMA.


Under FCC Rule 76.61(a)(2), you are required to respond to this letter in writing within 30 days of your receipt of this letter, and to either commence to carry the WACP signal in accordance with the terms requested in the attached carriage election letter or to state your reasons (if any) for believing that you are not obligated to carry the WACP signal.

It is our hope that carriage of the WACP signal on your cable system(s) within the DMA will commence promptly, and that this dispute will end with that carriage.

Ms. Rutherford-- This is an email confirming Tom's and my telephone conversation with you this afternoon concerning the October 15, 2012, letter which Verizon sent to us as the counsel and contact for WACP.

As discussed, the Verizon letter did not reflect current information or the obligations of the parties. WACP will not be making tests of signal quality tomorrow at the Verizon headend in the Philadelphia DMA. Mr. Anthony Van Lierop, the FIOS Network Engineer, has recently indicated to WACP that there was no signal problem, which means a good quality signal is present and no more tests are needed. Mr. Lierop did say that Verizon needed to do some tweaking (i.e. fine tuning or adjusting) to other existing equipment on its own tower to resolve a slight interference concern, and noted Verizon was separately working on what he termed a channel "capacity" issue. Resolution of the capacity issue is, of course, solely the responsibility of Verizon.

In the conversation, we indicated that Greg Kraft, an engineer working at WACP, will visit the Verizon tower site for the sole purpose of seeing any technical data as to any interference, discussing that issue with the Verizon engineers, and hearing when Verizon will correct the same, if they have not already done so. I hasten to add that Mr. Kraft has told us his understanding is that interference may not actually exist, so this may be resolved.

As Tom and I also noted, under FCC Rule 76.61(a)(2), it is Verizon's obligation to conduct any tests as to the signal quality. This is relevant to the second to last sentence in the October 15 letter which says "We will continue to discuss carriage with the station based on the results of Wednesday's testing." Presumably, you were referencing tests by WACP, but as noted WACP will not make tests and if any tests are needed, Verizon will be expected to perform the same as required by FCC Rule 76.61(a)(2). Finally, we mentioned that WACP had sent a letter to Verizon on June 6, 2012, electing mandatory carriage under the FCC's rules as a new station. WACP then followed up with the September 14, 2012, letter which is a demand for carriage under FCC Rule 76.61(a)(1). A response from Verizon is due within 30 days of receipt of that letter.

Attached is a screen shot taken from our search antenna of the WACP Ch.4 8VSB signal and the accompanying wide band impulse interference. As indicated in my conversation with you, a dedicated directional antenna will have to be placed on our mast to capture your signal. This antenna will be located at a lower position than our search antenna due to available space on our mast. Due to this lower mounting position of the permanent antenna, long term signal reception could be negatively impacted resulting in either an increase in interference level or a reduction in signal level of the desired station.

Please note that the peak hold function of the spectrum analyzer was used to capture the occupied bandwidth and amplitude of the interference.

I am off tomorrow, but will be in contact with you early next week to iron out the details for the site visit.



The engineers at FIOS showed me the results of their testing today. As it stands right now, they concede that we have met the requirements to be broadcast on FIOS. Our signal to noise ratio is within bounds to meet the FCC requirements for Must Carry Laws.

They are worried about a **potential problem** if current interference were to get worse or our power level were to decrease. Our signal to noise ratio **might** get worse. This scenario could be applied to every single broadcast station they currently carry.

Verizon continues to work with WACP regarding carriage of the station on FIOS TV. As you know, WACP's engineer, Gregory Kraft, visited the Verizon facility last week. During Mr. Kraft's visit, he observed on Verizon's test equipment noticeable interference with the signal Verizon receives from WACP. Verizon took steps to locate and immediately contact the subject of the interference for resolution to which there has not yet been a response. In addition, Verizon agreed to take daily samples of the signal to trend the behavior of the interference.

Before we are able to launch WACP, a structural analysis must be conducted to ensure that the tower and current antenna mast can support the newly proposed antenna and to assess the impact of tower loading on existing stations on the tower and public safety concerns. The current antenna structure is capable of supporting an additional 300 pounds. Although the proposed antenna for WACP weighs 150 pounds, potential icing and wind loading must be taken into account, as it is possible that these factors could overload the current antenna mast.

Finally, as the parties discussed during Mr. Kraft's visit last week, we are happy to work with the station to fiber in a direct connect from WACP to the Verizon facility. Please let us know if WACP would like to pursue this option.

Ms. Rutherford-- This is an email confirming Tom's and my telephone conversation with you this afternoon concerning the October 15, 2012, letter which Verizon sent to us as the counsel and contact for WACP.

As discussed, the Verizon letter did not reflect current information or the obligations of the parties. WACP will not be making tests of signal quality tomorrow at the Verizon headend in the Philadelphia DMA. Mr. Anthony Van Lierop, the FIOS Network Engineer, has recently indicated to WACP that there was no signal problem, which means a good quality signal is present and no more tests are needed. Mr. Lierop did say that Verizon needed to do some tweaking (i.e. fine tuning or adjusting) to other existing equipment on its own tower to resolve a slight interference concern, and noted Verizon was separately working on what he termed a channel "capacity" issue. Resolution of the capacity issue is, of course, solely the responsibility of Verizon.

In the conversation, we indicated that Greg Kraft, an engineer working at WACP, will visit the Verizon tower site for the sole purpose of seeing any technical data as to any interference, discussing that issue with the Verizon engineers, and hearing when Verizon will correct the same, if they have not already done so.
