
Dear Ms. Dortch:

On December 3, 2012 and December 4, 2012, Mr. Steven Pitterle, Manager – Carrier Relations for TDS Metrocom, LLC (“TDS”), spoke by telephone with Eric Ralph of the FCC’s Wireline Competition Bureau regarding the forthcoming special access data request in the above-referenced proceeding. Mr. Ralph asked about the extent to which TDS relies on unbundled network elements (“UNEs”) to serve residential customers as opposed to business customers in its operating states.

Mr. Pitterle indicated that TDS no longer markets UNE-based services to residential customers, but has done so in the past. Existing residential customers are allowed to retain their services if they so choose. Mr. Pitterle indicated that currently ****BEGIN CONFIDENTIAL**** ****END CONFIDENTIAL**** of the UNE loops TDS leases in their operating areas are associated with residential service.
