**MANDATORY CARRIAGE COMPLAINT**

Central Ohio Association of Christian Broadcasters (“COACB”), pursuant to Section 614 of the Communications Act of 1934, as amended, and Sections 76.7 and 76.61 of the Commission’s Rules, hereby files this Complaint requesting that the Commission order Time Warner Cable (“Time Warner”) to carry qualified low power television station WOCB-CD, licensed to serve Marion, Ohio (“WOCB,” or the “Station”) in accordance with the Commission’s mandatory carriage rules and policies in the communities identified on Exhibit 1 hereto (the “Communities”) for the remaining duration of the current must carry election cycle, expiring December 31, 2014.<sup>1</sup>

**I. COACB’S COMPLAINT IS TIMELY FILED BASED ON TIME WARNER’S DENIAL OF COACB’S FORMAL CARRIAGE REQUEST**

In a letter dated September 13, 2012 (the “Carriage Request”), COACB notified Time Warner that its failure to carry the Station in the Communities constituted a failure by Time

Warner to comply with the Commission's mandatory carriage rules.<sup>2</sup> A copy of the Carriage Request is attached to this Petition at its Exhibit 2. The Carriage Request demanded that Time Warner commence carriage of the Station on all of Time Warner's systems serving the Communities (the "Cable Systems").

Time Warner sent a response to the Carriage Request dated September 19, 2012, in which Time Warner requested clarification of COACB's offer to grant Time Warner a private copyright license in the programming carried on WOGB. That September 19, 2012 letter did not grant or deny carriage of the Station. COACB responded to that letter on September 28, 2012, and has not received any response.<sup>3</sup> Pursuant to Section 76.61(a), Time Warner's failure to respond within 30 days of its receipt of COACB's September 13 Carriage Request is deemed a denial of that carriage request.

Section 76.61(a)(5) provides that any must-carry complaint must be filed within sixty days of either a cable operator's denial of a carriage request or the expiration of the thirty-day response period set forth in Section 76.61(a)(2). COACB's Carriage Request was sent on September 13, 2012, and Time Warner's response under Section 76.61(a)(2) would have been due by no later than Monday, October 15, 2012. This Complaint, which is being filed on December 11, 2012, is therefore timely filed under Section 76.61(a)(5).<sup>4</sup>

## **II. THE STATION IS ENTITLED TO MANDATORY CARRIAGE ON THE SYSTEMS**

Under the Communications Act and the Commission's Rules, a station is entitled to mandatory carriage on certain cable systems if it is a "qualified low power television station," as defined in Section 76.55(c) of the Commission's Rules. Section 76.55(d) sets out six requirements for a "qualified low power television station:"

- (1) Such station broadcasts for at least the minimum number of hours of operation required by the Commission for full power television broadcast stations under part 73 of this chapter;
- (2) Such station meets all obligations and requirements applicable to full power television broadcast stations under part 73 of this chapter, with respect to the broadcast of nonentertainment programming; programming and rates involving political candidates, election issues, controversial issues of public importance, editorials, and personal attacks; programming for children; and equal employment opportunity; and the Commission determines that the provision of such programming by such station would address local news and informational needs which are not being adequately served by full power television broadcast stations because of the geographic distance of such full power stations from the low power station's community of license;
- (3) Such station complies with interference regulations consistent with its secondary status pursuant to part 74 of this chapter;
- (4) Such station is located no more than 56.32 km (35 miles) from the cable system's principal headend, as defined in § 76.5(pp), and delivers to that headend an over-the-air signal of good quality;
- (5) The community of license of such station and the franchise area of the cable system are both located outside of the largest 160 Metropolitan Statistical Areas, ranked by population, as determined by the Office of Management and Budget on June 30, 1990, and the population of such community of license on such date did not exceed 35,000; and
- (6) There is no full power television broadcast station licensed to any community within the county or other equivalent political subdivision (of a State) served by the cable system.

As shown below, WOCB satisfies each of these requirements for each of the Systems.

WOCB broadcasts programming 24 hours per day 7 days per week, well more than the minimum hours required for full power television stations under the Commission's rules. WOCB also satisfies the programming requirements set forth in Section 76.55(d)(2). As shown in the attached Declaration of Jonathan Aiken, in addition to syndicated religious programming, WOCB broadcasts children's programming, local events such as parades, and other local interest programs. WOCB carries a locally-produced home shopping program offering home delivery to local residents, including the elderly, handicapped, and others who are homebound. The unique programming provided by WOCB addresses local needs that are not adequately served by any other television station.

As required by Section 76.55(d)(3), WOCB complies with all interference regulations applicable to it under the Commission's rules. WOCB's transmitter site is also located less than 35 miles from the Systems' principal headends, and delivers a good quality over-the-air signal to those headends. WOCB's transmitter site is located at latitude 40 deg. 18 min. 47 sec.; longitude 83 deg. 3 min. 4 sec.<sup>5</sup> Based on information provided to COACB by Time Warner in a letter dated February 21, 2012, this location is less than 35 miles from Time Warner's Columbus, Ohio and Marion, Ohio headends.<sup>6</sup> COACB believes that WOCB provides a good quality over-the-air signal to both the Columbus and Marion headends, and at no time in its correspondence with COACB has Time Warner suggested to the contrary.

The community of license of WOCB is Marion, Ohio, which is located in Marion County. Marion County is not located within any Metropolitan Statistical Area (MSA), and, as

of June 30, 1990, had a population of 34,075.<sup>7</sup> All of the Communities in which COACB is requesting carriage are located in counties outside of the largest 160 MSAs. Champaign, Coshocton, Crawford, Hardin, Hocking, Knox, Logan, Marion, Morgan, Perry, and Wyandot counties are all located outside of any MSA.<sup>8</sup> There are no full power television stations licensed in any of the counties in which the Communities are located.

Pursuant to Section 76.56(b)(3) of the Commission's Rules, a cable system with more than 35 usable activated channels that has not used at least one-third of those channels to carry local commercial television stations shall carry two qualified low power television stations. COACB understands that the Time Warner systems serving the Communities all have more than 35 usable activated channels and that those systems use less than one-third of that capacity to carry local commercial television stations. COACB also understands that Time Warner is not currently carrying two qualified low power stations in the Communities, except for those Communities where WOCB is already carried.<sup>9</sup> Accordingly, WOCB is entitled to carriage as a qualified low power television station on the systems serving the Communities.

### **III. CONCLUSION**

COACB is clearly entitled to mandatory carriage of the signal of WOCB-CD on cable systems operated by Time Warner in the Communities. WOCB is a qualified low power station, and is entitled to carriage pursuant to Section 76.56(b)(3) of the Commission's Rules. COACB has properly elected mandatory carriage, has notified Time Warner of its failure to comply with

the Commission's mandatory carriage rules with respect to WOCB, and has requested that Time Warner commence carriage of the Station on all of its Cable Systems serving the Communities. Time Warner has refused to carry the Station in the majority of the Communities and has failed to respond to COACB's formal request for carriage. For the reasons set forth herein, COACB hereby respectfully requests that the Commission order Time Warner to carry the Station in accordance with the mandatory carriage rules and policies.

Dear Mr. Harding:

As you know, the Central Ohio Association of Christian Broadcasters (“COACB”) is the licensee of Class A television station WOCB-CD. WOCB-CD is licensed to the community of Marion, Ohio. Time Warner Cable (“TWC”) operates one or more cable television systems serving communities identified on the attached Exhibit A (the “Cable Systems”). This letter is being sent on behalf of the COACB to formally demand carriage of WOCB-CD on the Cable Systems identified on the attached list in accordance with Sections 76.56(b)(3) and 76.61 of the rules of the Federal Communications Commission (the “FCC”).

As demonstrated in previous correspondence with TWC, WOCB-CD is a qualified low power station under Section 76.55(d) of the Commission’s rules. WOCB-CD broadcasts more than 16 hours per day every day of the week. WOCB-CD meets all obligations and requirements applicable to full power television stations with respect to the broadcast of non-entertainment programming; programming and rates involving political candidates, election issues, controversial issues of public importance, editorials, and personal attacks; programming for children; and equal employment opportunity. The programming provided on WOCB-CD addresses local news and informational needs of the communities served by the Cable Systems which are not being adequately served by full power television broadcast stations.

WOCB-CD is duly licensed by the FCC, and complies with all relevant interference rules. WOCB-CD's transmitter site is located less than 35 miles from the principal headend of the Cable Systems, as the location of that headend was provided in your earlier correspondence. WOCB-CD's community of license and the franchise area of the Cable Systems are all located outside any of the 160 largest Metropolitan Statistical Areas, and no full power television station is licensed to any community within the county served by each Cable System.


In addition, COACB has agreed to indemnify TWC for any increased copyright liability arising from TWC's retransmission of WOCB-CD and has offered to grant TWC a private copyright license to carry the station's programming in any areas in which WOCB-CD would be considered a distant signal for copyright purposes.

Based on the foregoing, there therefore is no lawful reason for TWC to refuse to carry WOCB-CD on the Cable Systems. Thus, pursuant to Section 76.61(a)(1) of the rules of the FCC, COACB hereby notifies you that we believe that TWC has failed to meet its carriage obligations and we demand mandatory carriage of WOCB-CD in the communities served by the Cable Systems.

Although this notice letter is necessary to preserve COACB's rights under the FCC's rules, we continue to hope that we can arrange for WOCB-CD's carriage on the Cable Systems without resort to the FCC's complaint procedures.


Dear Mr. Kirkpatrick:

Thank you for your letter of September 13, 2012.<sup>1</sup> Your letter states that “COACB has agreed to indemnify TWC for any increased copyright liability from TWC’s retransmission of WOCB-CD and has offered to grant TWC a private copyright license to carry the station’s programming in any areas in which WOCB-CD would be considered a distant signal for copyright purposes.”

As you know, you were advised by TWC on June 28, 2012 that it estimates additional semi-annual copyright liability of at least \$171,000 should it elect to carry WOCB-CD in communities where it would be considered distant for copyright purposes. In your response dated July 27, 2012, you stated that COACB “is willing to grant TWC a private copyright license in all programming broadcast on WOCB-CD for the rebroadcast of that programming in the areas in which COACB has requested carriage.”

Please clarify whether your September 13th letter is now offering TWC with the choice of either cash payment to cover its increased copyright costs from the carriage of WOCB-CD or a private license.



As noted in COACB’s July 27 letter, COACB is willing to grant a private copyright license to TWC, which COACB believes will avoid the possibility of any increased copyright liability. 

#### Lights Camera Shop

Every Friday night from 8:30pm – 11:30pm

This program is different from anything else on television. Lights, Camera, Shop is hosted by a mother and son duo Carolyn and Jonathan Aiken. The program's hosts have been described as plain, down right, entertaining. During the program the mother son couple sell numerous wholesome, practical bargains to further our non-profit Christian ministry. However the program is more than just a shop at home program, due to the hundreds of prayer requests that are received by our phone staff during the show every month. As the requests come in Jonathan and Carolyn stop selling whatever they were selling and invite the public to pray along with them for the need of their fellow man. We have found that many people call because they feel that the hosts care for them and they want someone to listen and pray for them by first name.

The program is geared toward those who have trouble getting out, the disabled, and the homebound. Also, anyone looking for a bargain will surely find them here on this program. On further note, many elderly have trouble figuring out sales tax so all items are sold in even dollar amounts with the tax included. Because of the volume of merchandise Lights, Camera, Shop sells each week, our distributors give us greatly discounted prices. Usually we sell items for about half of the price that they sell for in stores. We sell food, practical merchandise, close outs, jewelry, tools, electronics, seeds, gardening supplies, toys and many items never before seen before on television.

The show is extremely popular and here at the Central Ohio Association of Christian Broadcasters we often brag that we own television on Friday nights from 8:30 – 11:30. This is definitely not your normal shopping program. Whole neighborhoods join together at each other's houses to order pizza, watch, and participate on this program. Walk down the halls of the hospitals, nursing homes, jails and prisons and you will find most televisions tuned in to this program. We chuckled when we heard a jailer from the Multi-county jail tell us that one of his inmates announced to all the others in the cell block that he planned on watching Lights, Camera, Shop and the TV better be on channel 39 because he wasn't afraid to go to the hole. To my knowledge the whole cellblock still watches this program every week.

Prayer Line Live

Monday through Friday 8:00- 8:30

Prayer Line is a live call in prayer program hosted by various churches and religious groups here in central Ohio. Just a few of the hosts for Prayer Line include Joe Koontz and Bob Asadorian from Columbus, Jill Street from Mt. Vernon, Richard and Jeanie Stevens from Marysville, Bob Evens from Kenton, David and Carolyn Aiken from Edison, John and Edith Peterson from Caledonia, Kim McFann from Mt. Gilead, Ron from Upper Sandusky, Tom Callahan from Lewis Center, and Larry and Susan Hatfield from Findley. During the program our viewers call in for their various needs. These prayer requests can be anything from an eight year old student worried about a math test on Monday, to someone's Grandmother had a massive heart attack and is in Morrow County General Hospital. During each request we take time to call out every request by first name along with their afflictions. At that time, we invite the public to pray along with us, creating the largest prayer meeting Monday through Friday. This program is a free service to all the hosts and churches involved. We invite everyone to tune in at 8:00 to see what Prayer Line Live is and has to offer our local communities. We know and believe in the power of prayer, and the family members who have had love ones have been healed and delivered from their sicknesses and afflictions do too. There have been so many seemingly impossible prayer requests that have been answered in nothing short of a miracle.

Naomi Beckel called in crying because the Doctors at Ohio State University Hospital told her that her son Tom Beckel had about a half hour to live. He had a flesh eating bacteria that was not only consuming his flesh but was releasing poison Toxins and their level had reached the fatal level. He would be gone in a half hour. There was absolutely no hope for his recovery. The TV audience was told the diagnosis and asked to pray. A half hour came and went. Tom was critical but still alive. The next day, Tom was still critical but improving slightly. His doctors kept using the word miracle. Tom made a complete recovery. Tom's doctor said there had been 53 similar cases at Ohio State Hospital and Tom was the only one that lived. Naomi says that the station brought all those people together to pray and God heard their prayers. Tom is a salesman for McDaniel's Motors in Marion, Ohio. Go see him if you want to see a miracle.

### Parades, Fairs and Special Events

The COACB carries local Parades, Fairs, and special events, just a few of those that have been shown are The Marion County Fair, The Wyandot County Fair, The Crawford county Fair, The Union County Fair, The Mt. Gilead Gourd Show, The Kenton Coon Chase, The Bucyrus Bratwurst Festival, The Delaware County Fair and highlights of the Ohio State Fair. We received a touching letter from an inmate at the Marion Correctional Institute thanking us for covering local events. He stated that if it were not for the cameras and microphones of the COACB, he would know very little about the town where he had spent the last five years of his life.

### Public Affairs

The COACB airs Public Affairs covering everything from Veteran Services, Hospice, Services for the elderly, Estate planning, and Preventing Crimes against the elderly, Gardening tips. Service and hobby clubs are also highlighted. The program is very popular and local groups strive to obtain a guest appearance on Public affairs. Some that have appeared on the show are US Treasurer Mary Ellen Withrow, Ohio Secretary of State Ken Blackwell, Marion County Sheriff Department, The Creators Guild of Marion Ohio, The hobby Club, Numerous Fire Departments. The Lyons Club from Green Camp, Marion County Veterans Services, Hospice of Morrow County, Jobs and Family Services from several counties, Children's Services. Also, every January we host the Martin Luther King Celebration in Studio A at COACB. Thirty Central Ohio Churches take part in the event from all over central Ohio. With that being said, our Studio A can seat 350 people but because of our turnout this year we realized it's obvious we do not have enough seats and are looking to expand the event next year.

### The Good News

News comes from many sources and other major media ignores most good news. Our stations strive to report these unreported news items and help the community feel good about itself. Just a few of the reports that we have covered are, Fund raising activities for Big, Brother and Big Sisters. Establishing Community Gardens, Church Projects, Special projects for military families, Efforts to raise money to build community pools, and establishing and expanding food pantries.

### Hymn Time

Hymn Time is a very entertaining program featuring Jimmy Dutton and various Blue Grass singing groups. People often drive from as far as 100 miles away to see this program in person. Come early if you want a seat. You probably will not

find a parking space at COACB because of the large crowds but other businesses in the area permit parking in their lots for persons coming to this program.

### Tour Groups

TV39 has become a tourist attraction with tour busses coming from as far away as Michigan to tour its facilities. Before the recession approximately sixty tour groups toured our facilities each year. That number is now down to approximately 40 because of the high price of gasoline

### Word of Truth (Sunday 1:00 PM)

This program is designed to serve the disabled, the home bound, the frail, and the elderly. We are told that when a person can no longer get out to attend their church, the church will visit very often the first year. The second year, they are visited occasionally but by the third year, no one from their home church visits. Those in jails, nursing homes, and prisons have a similar fate.

The Word of Truth Broadcast put on by My Community Church seeks to fill the needs of those who are home bound. The church is quick to tell everyone that it is a church without walls and its worship area extends into every home where the program is viewed. It is truly a two-way program with up to 40 prayer and praise reports coming in each week by telephone.

### Battle of the Brains

This is a game show featuring local high school teams, including teams from the following School Districts Elgin, Ridge Dale, River Valley, and Pleasant. Not only do parents and relatives attend during the production of this program. This program is watched over the air as well as the Internet. Recordings of the program are duplicated and mailed to friends and relatives across the USA.

None of the local programs listed above are broadcast on any other station.
