**STREAMLINED FINANCIAL HARDSHIP WAIVER CERTIFICATION**

1. By this pleading and the attached certificate, KMYA, LLC (“Licensee”), licensee of Station KKYK-CD, Facility ID 57545, Little Rock, AR, hereby certifies that KKYK-CD requires a one-year delay to achieve compliance with the requirements of the Commercial Advertisement Loudness Mitigation Act (the “CALM Act”) and requests a waiver of the December 13, 2012 deadline for compliance.

2. Pursuant to the streamlined waiver process set forth in the Commission’s December 13, 2011 *Report and Order* in this proceeding, Licensee requests waiver for KKYK-CD as a “small broadcast station.”<sup>1</sup> Under the procedures adopted in the *Order*, station seeking a waiver on this basis must certify to the Commission that it qualifies as a “small broadcast station” and that it requires a delay of one year to obtain specified equipment to avoid financial hardship.<sup>2</sup>



3. As set forth in the attached Certification of a Managing Member, Licensee certifies that KKYK-CD satisfies the definition of “small broadcast station” by virtue of having less than \$14 million in gross annual receipts. The certification recites that to avoid financial hardship, the Licensee requires a one-year delay to obtain certain the equipment necessary for KKYK-CD to comply with the Commission’s CALM Act requirements.

4. Accordingly, KMYA, LLC respectfully requests a one-year waiver for KKYK-CD to comply with the CALM Act.



**CERTIFICATION OF LARRY E. MORTON**

I, Larry E. Morton hereby certifies as follows:

1. I am a Managing member of KMYA, LLC.
2. KMYA, LLC is the licensee of Station KKYK-CD, Little Rock, AR (Facility ID 57545).
3. During calendar year 2011, the stations had less than \$14 million in annual gross receipts, based on gross receipts received during the year. It is anticipated that KKYK-CD will also have less than \$14 million in annual gross receipts for 2012.
4. To achieve compliance with the Commission's CALM Act requirements, I estimate costs of in the range of \$20-25,000, for encoding and monitoring equipment and software the enable KKYK-CD to be able both to ensure that the audio level of commercials is not excessive and to check compliance when as it may be required.
5. To avoid a financial burden that we cannot afford to meet at this time, KMYA, LLC requests a one-year waiver of the Commission's CALM Act requirements for KKYK-CD.
