Dear Ms. Dortch:

On December 3, 2012, I spoke by telephone with Jodie May and Christopher Sova of the Wireline Competition Bureau concerning the above-captioned proceeding. I urged the Commission to promptly grant the transaction. A grant by the end of the calendar year is essential to address Wavecom's financial difficulties as well as to protect employee health insurance plan participation in 2013.

I enclose a revised description of services provided in specific buildings in the State of Hawaii where both HTI and Wavecom currently have facilities. This appendix revises, and therefore should replace, the information provided in Appendix B, which was appended to Letter from Gregory J. Vogt to Marlene H. Dortch, FCC, Docket No. 12-206 (Nov. 29, 2012).
