COMMENTS OF GENERAL COMMUNICATION, INC.  
ON THE CAF PHASE 1 UNSERVED AREAS LIST

General Communication, Inc. (“GCI”) hereby files these comments in response to the Commission’s Public Notice of December 5, 2012, seeking public input on its list of potentially unserved census blocks.<sup>1</sup> GCI has reviewed this list. Attached is a list of census blocks that the Commission has listed as either “unavailable” or “partially unavailable” for fixed terrestrial broadband service with advertised speeds of at least 3 Mbps downstream and 768 kbps upstream, but within which GCI provides such broadband service. GCI is also providing the Commission with maps of these census blocks indicating the scope of the area in which it offers such service.<sup>2</sup> GCI provides broadband in these areas either through GCI Cable, for cable-based broadband service, or through GCI Communication Corp. for fixed wireless service.


